Who we are and where we operate?

Giant Leaps Begin with a Single Step...

In 2014, the Journey started as a member of CARE - the Eco Club of Sri Venkateshwara College of Engineering, supported by EMAI. We started a survey to identify areas in Chennai where House sparrow population is still existing. Based on the survey it was found that sparrow population is thriving in North Madras (Thiruvottiyur, Tondiarpet, Royapuram etc.,) and in pockets of Chintadripet, Triplicane, Urapakkam, T.Nagar. A step further, the members of EMAI and CARE started distributing nest boxes specially designed for House sparrow nesting and deter crows from taking away eggs from the nest. The result was very promising as the nest boxes were immediately adopted by the House sparrows.

We started our journey with the Sparrow conservation project and extended to other projects such as Waste Management, Biogas, String Arts. We unified people working in diverse fields unite to rejuvenate nature by various activities. We at this young age spend our leisure time creating awareness among students about nature conservation. Our success lies in incepting the idea in young minds and creating the opportunity to make tiny homes with their own hands. Our supporters are all like-minded friends who support monetary benefits and other voluntary actions. Our team members are highly experienced in connecting with society and in dealing with societal problems.

Koodugal (NEST - Network for Environment sustainability Trust) as a unified team is trying to recreate, reduce and solve.

By recreating a space for sparrow in your homes we are trying to save a species on the verge of extinction and thereby can balance the food chain.

By reducing plastic waste, we can make the earth a better place to live.


